Going home on Peritoneal Dialysis (PD)

This leaflet aims to answer any questions you may have now that you are going home on Peritoneal Dialysis (PD). If you have any queries at any time please do not hesitate to telephone us, the telephone numbers are at the end of this leaflet.

Baxter Homecare is the company who will deliver your fluid, disconnect caps, connection shields and ancillaries to you. They will send you a list of telephone numbers and delivery dates up to the end of the calendar year.

If at any time you are unable to be at home for a delivery, then please contact the Baxter Homecare Team on 0800 0234 002, from a mobile 0370 6099 101, or email homecarecs@baxter.com as soon as possible to re-arrange your delivery.

Please note if your regime changes it is important that you inform Tracy Spencer on 024 7696 7732 or the Baxter Homecare Team on 0800 0234 002 or from a mobile on 0370 6099 101 as soon as possible as you may not have enough fluid to last until your next scheduled delivery.

Delivery

The driver will carry your fluid to your usual storage area. He will rotate your stock so that the new supplies are at the back. Please check that you have the correct delivery, size of bag, strength and enough boxes for the month. In the event of an incorrect delivery, or any problems, please report this to the Baxter Homecare Team on 0800 0234 002 or from a mobile on 0370 6099 101.

Renal waste

Some of the local councils will collect your medical waste from your home. Your empty PD bags, any dressings and tapes are all that need to be put into these bags.

If you do not have enough space in your cardboard recycle bin for the boxes you can ask your local council to provide you with an additional bin for these.

Your first weekly medical waste collection will be on

And then every thereafter.

Please note that some local council's do not class peritoneal waste as medical waste, and therefore do **not** have separate medical waste collections. Currently these councils are Stratford, North Warwickshire, Warwick, Walsall, Daventry, Birmingham City, Whychaven and Redditch Borough. If you live in one of these council areas you will be asked to bag your waste into black sacks and put the waste in with your domestic waste. If you require an additional bin to cope with the increased amount of waste this is available by contacting your local council.

Holidays

Although it may be too early to think about taking a holiday, it is worth knowing that you can plan for a holiday on PD, whether it is in the UK or abroad, through Tracy Spencer. Your fluid will be delivered to your holiday destination in time for your arrival.

If you are thinking about a holiday abroad, it is worth checking with Tracy Spencer that the country in question will accept PD fluid and which PD systems are available. Please remember that some countries need as much as **three months** notice to ensure that everything is arranged on time. So as soon as you seriously think about taking a holiday abroad, please contact Tracy Spencer on 024 7696 7732 as soon as possible to avoid disappointment.

When all the arrangements have been made, you will receive written confirmation of your holiday dates and the amount of PD fluid and

disconnect caps[△]which will be waiting for you at your holiday destination. It will also include details of the nearest hospital or clinic that you can contact in an emergency.

Please remember to take this leaflet with you in case you need to contact the PD centre as it contains important telephone numbers and contact details should you need them.

Please note that no ancillaries will be delivered for a holiday, you will be requested to take these items with you. Ancillary items are: paper towels, alcohol gel, dressings, tapes and yellow refuse bags.

You will need to make local enquiries about the procedure for PD waste disposal as other countries treat PD waste differently.

The following table contains information from Baxter Travel and gives the notice periods for each of the different countries and the availability of different fluids.

Please note there is a maximum limit of 56 days' supply per holiday.
